PUBLIC COMMENTS AND DISCUSSION:

Kay mentioned that today is the Marine Corp. birthday.

POSSIBLE ACTION ITEM: Approval of minutes from the October 13, 2022 meeting Elizabeth made a motion, Paul seconded and the minutes were approved as written.

POSSIBLE ACTION ITEM: Discussion and possible action on foundation renovation project. Public works is looking at plumbing the south lawn and then new top soil, but they are currently down five people. Eric is looking at hydro seeding rather than sod. The library is done with payment. Beyond the foundation project, Public Works is going to commissioners for approval to look for bids on the library roof. It will be a metal roof and should be done within the next fiscal year.

POSSIBLE ACTION ITEM: Discussion and possible action on an updated strategic fiveyear plan.

Director made a request for board members to workshop on the new five-year plan. Kay and Kellie are interested in working on it. It will be added to the agenda going forward. Kay suggested a smart board for the meeting room. Elizabeth suggested talking to Pat (emergency management) about the smartboards purchased by the county.

POSSIBLE ACTION ITEM: Discussion and possible action regarding the meeting room policy and whether to allow after hour meetings.

Current policy says it is up to the Director. Would like to change the policy to only allow up to 7pm on Tuesdays and Wednesdays. The changes will be put to a vote at the next meeting.
